APPLICATION FOR MEMBERSHIP

Thank you for your interest in Dana West Yacht Club.

Please complete the attached application and return it to the Club Office or a Flag Officer. We will give it prompt attention.

The current fees at DWYC are as follows:

Initiation fee: \$1,000.00 - One-time, non-refundable

Dues: Membership is a month-to-month commitment to be paid in advance on the 1st of each month with an automatic debit to credit card only:

PAID MONTHLY –

- \$110/month + \$4 processing (Regular Membership)
- \$55/month + \$4 processing (Associate or Racing Memberships)

OR, PAID ANNUALLY –

- Annual Dues are \$1,320 (Regular) or \$660 (Associate/Racing) may be paid on or before July 1st each year
- No processing fee save \$48 annually
- Annual period is July 1st to June 30th and prorated at time of member acceptance following Board approval.
- There are no food or bar minimums at DWYC

The application process is as follows:

- Complete and sign a Membership Application, obtain the required Sponsor signatures, then **turn in your initiation fee** (which will not be deposited until your application is posted in the club).
- **Provide a letter outlining why you desire membership, your boating history (if any), how you learned about DWYC and how you can benefit the club.**
- At the next Board meeting, which occurs on the 3rd Tuesday of the month, your application will be brought up for posting. It is posted for a minimum of 28 days.
- At the subsequent Board meeting, the Board votes on your application. At that time, your membership will be **approved or disapproved**.
- ***IF APPROVED and UPON RECEIPT OF YOUR DUES, your DWYC Membership will become official.***
- Once your Membership is official, you should contact the Vice Commodore at vicecommodore@dwyc.org or call the DWYC office (949) 661-1185 to arrange receipt (pick up, mail) of your membership packet, which will include your membership cards and name badge(s).
- The process will take approximately 30-60 days, depending on when your application is submitted.

AUTHORIZATION AGREEMENT FOR AUTOMATIC PAYMENTS

Check all that apply: (Club Dues) (Initiation fee)

I hereby authorize Dana West Yacht Club, hereinafter called "DWYC", to charge my account (named below), for amounts due (as determined by DWYC). This authorization does not require the club to initiate such charges and I expressly acknowledge I am responsible for my payments regardless of whether DWYC exercises its authority to charge account and regardless of whether there are sufficient funds available to satisfy the charges. I expressly agree DWYC's liability under this authorization shall be limited exclusively to amounts which are negligently or intentionally debited by DWYC and which exceed my annual payments.

The contract between DWYC and the Member is 1 month automatically renewing unless 30 days notice is provided by either party. A person may wish in advance all 12 monthly installments at one time at which time they will receive additional consideration of not paying the \$4.00 per month administration fee. In the event of termination during the period of time in which the Applicant has paid these 12 monthly installments in advance, the Member may not receive reimbursement of any unused installments. The parties agree that adequate consideration has been paid and received for these agreements. The Member is responsible at all times for knowledge of and compliance with all house rules and bylaws for DWYC.

THIS AUTHORITY IS TO REMAIN IN EFFECT UNTIL DWYC HAS RECEIVED WRITTEN NOTIFICATION FROM ME OF ITS TERMINATION IN SUCH TIME AND MANNER AS TO AFFORD THE CLUB AND BANK A REASONABLE OPPORTUNITY TO CANCEL.
