



HOUSE RULES

MEMBERS AND GUESTS

1. You and your spouse or co-member, as applicable, represents a single membership of Dana West Yacht Club (“Club”). Per the Club’s By-Laws, this includes unmarried dependents of a Regular Member who are residents of the Regular Member's household, who have not yet reached the age of 21 years.
2. All members need to show their current membership cards upon entering which will be recorded. Guests may be asked to show their identification cards.
3. Guest privileges at the Club are four guests per membership number before 4:00 pm and two guests per membership after 4:00 pm, unless otherwise approved by the Commodore, Vice Commodore, Rear Commodore or a member of the Board of Directors.
 - Members are responsible for the conduct of their Guests at all times.
 - Guests are not permitted at the Club without a sponsoring Member being present on the Club premises.
 - Guests must follow the same Club Rules and Policies as Members.
5. A Member event (“Event”) may be requested through an Event Form that is turned in and reviewed and approved by the Commodore and Food and Beverage Committee. A member event is defined as a gathering of ten or more members or guests.
 - The Event Form must be submitted at least one week prior to the Event to provide sufficient time for consideration and approval.
 - If approved, a signed Event Agreement may be provided for your review and signature. Agreements must be signed and returned to the Club before the event date.

6. For Club-approved Member Events:

- You may access the designated Event area 30 minutes prior to the Event's scheduled start time.
- While you may arrive early to decorate your reserved table for an Event, a member from your party must remain with your table at all times prior to your Event's scheduled start time.
- All non-member guests must leave the Club no later than 30 minutes after the Event's scheduled end time.
- If requested, a guest list must be provided in writing at least 48 hours prior to your Event.
- No guests exceeding the number approved shall be permitted at the Event without the prior permission of the Commodore, Vice Commodore or Rear Commodore.

ANIMALS

Animals are not allowed on Club facilities at any time without prior permission. This includes "service dogs", whose status must be confirmed. "Emotional support animals" are not permitted, except for service dogs trained to perform a particular function relating to the disability. Consistent with the ADA requirements, service dogs must remain under the control of their handlers and harnessed, leashed or tethered while on Club premises unless these devices interfere with the service animals' work or the person's disability prevents use of these devices.

CHILDREN

Children under the age of 21 are to be seated with their parents and be supervised by an adult while on Club premises at all times.

CONDUCT

1. The Club reserves the right to refuse or limit service to anyone for any reason at any time. The Club further reserves the right to take any reasonable action to enforce these and other applicable rules or laws.
2. Bare feet and bathing suits are not permitted in the Club at any time. After 5:00 pm, bathing suit cover ups and tank tops for men are not permitted in the Club.
3. **No conduct shall be permitted, which unreasonably interferes with the quiet enjoyment by members or guests or interferes with normal operations of the Club, including, but not be limited to, vulgarity, abusive language, combative behavior, fighting, yelling and inappropriate attire.**

ALCOHOL (ABC)

1. No alcoholic beverages purchased in the Club are allowed beyond the front door or beyond the back doors of the rear patio at any time, except as provided by ABC and local guidelines.
2. No open alcoholic beverages originating from outside the Club may be brought onto the Club premises at any time.

GUEST DOCK

The primary use of the guest dock is for visiting cruisers from other clubs. The guest dock is available for use by Club members on a limited, first come-first served basis, with approval by the Dock Master. Any Club member granted the privilege of using the guest dock must be available to be contacted and be prepared to depart immediately if requested to do so by the Dock Master.

RECIPROCAL CLUB MEMBERS

1. Reciprocal visitors may visit the Club two times per month. A waiver of this limitation may be granted by the Commodore, Vice Commodore, or Rear Commodore.
2. Reciprocal visitors are-not allowed to sign in guests without prior permission from the Commodore, Vice Commodore or Rear Commodore.
3. Reciprocal Visitors must sign in and show their club's membership card for entry to the Club. They also must properly wear their home club's name badge or a Club visitor name badge at all times.
4. Our House Rules and Policies apply to visiting Reciprocal Club Members.

VIOLATIONS OF THESE RULES

Violation of these rules may result in removal from the Club or other such remedies as provided by the Club's By-Laws.



HOUSE RULES
